Purpose:

Marlborough School Science Academy will meet the statutory requirements for Citizenship and follow the programmes of study for PSHEE, known to the school as PSHCEE.

Implementation:

- The programmes of study for PSHCEE is mapped and developed by the PSHCEE Coordinator.
- The PSHCEE programme is delivered through PSHCEE lessons at key stage 3 and across the curriculum subject lessons with specific PSHCEE learning objectives and tasks. PSHCEE events and activities are organised to complement the delivery throughout the curriculum.
- Each week the school follows a Collective Reflection Theme through assemblies and form times which also contributes towards the programme.

Arrangements for monitoring and evaluation

- A record is kept of students' progress using the school's systems which provide evidence of progress towards the attainment target. Students are encouraged to review and record their own progress. Teachers complete grade cards which measure attainment regularly. Assessment will be on-going.
- The PSHCEE Coordinator, Directors of Learning, Senior Learning Managers and the teaching staff carry out an evaluation of the PSHCEE programmes including any visiting speakers following each PSHCEE activity.

• Monitoring of the delivery of PSHCEE takes place through lesson observations, work scrutinies and student interviews. • Tutor times are observed to monitor the delivery of the reflection themes.
