

The Marlborough Science Academy Mobile Technology Agreement

In order for you to be granted permission to bring your mobile device to school you must agree to the terms laid out within this agreement and successfully complete the four online safety modules.

Where no contract exists, a confiscated phone will only be returned upon completion of a lunch time detention, a fully signed mobile technology agreement and successful completion of the school's online safety modules.

For my own personal safety:

- I am aware that the school will look at the way I use ICT and mobile devices within The Marlborough Science Academy and its community.
- I will not share my username / password or use any other students or teachers username / password or give out any personal information about myself or others when I am communicating.
- I will tell a member of staff straight away if I see or hear any rude or inappropriate material or messages when I am online or through the use of technology.
- I will **not charge** any of my mobile devices using the schools facilities.
- I agree **not to contact members of my family during school hours** unless given permission to do so by a member of staff.
- I will use only **my school email address** for all school-related communications.

I understand that everyone has equal rights to use ICT technology as a resource and:

- I know that the school's ICT are needed for educational use and that I will not use them for my own personal use **unless I have permission to do so by a member of staff.**
- I will not enter a classroom with my headphones or phone visible or use them in a lesson when a member of staff displays the red mobile phone sign and I will abide with the teachers direction of use when the green sign has been displayed.

I will act as I expect others to act toward me:

- I will respect others' work and property and will not open, copy, remove or change any other student's files, without them knowing about it and having their permission.
- I will be polite and responsible when I communicate with others, I will not use aggressive or rude language.
- I will not take, show or post images, videos or sound recordings of anyone without their permission, even if they are only in the background
- I will fully respect a member of staff's decision to not allow mobile devices to be used in a lesson.





I know that the school has a responsibility to keep the security and upkeep of the ICT it offers me:

- I will only use my own devices before school starts, at break or lunchtime, after school or **when** given clear permission by a member of staff.
- I understand that, if I do use my own device in school, I will follow the rules set out in this document, and if I break these I know what the sanctions will be.
- I am aware that the school will take **no responsibility** if I lose or have my mobile device stolen in school or while travelling to and from school. I know the **school accepts no responsibility for replacing lost, stolen or damaged mobile devices**.
- I will not install or attempt to install programmes of any type on a school machine nor will I try to change computer settings.
- I will not attempt to bypass the internet filtering systems or remove myself from the school's IT domain.
- I understand that my area on the network is for storing files related to schoolwork and that this area is subject to checks by IT staff.
- I will not attempt to log into the school IT infrastructure using a VPN or Tor related browser.

I understand that I am responsible for my actions, both in and out of school:

- I understand that the school also has the right to take action against me if I am involved in incidents of inappropriate behaviour that are in this agreement, when I am out of school and where they involve me within the school community.
- I understand that my actions using must not bring the school into disrepute and if they do, I will face sanctions.
- I understand that these rules are designed to keep me safe and if they are not followed, school sanctions will be applied and my parent/carer will be contacted.
- I am aware that I must not take any mobile device, including 'smart watches', into an examination venue and should I be caught with a device on me I will face disciplinary action as sanctioned by the Headteacher and Examinations Officer. As a result the exam board may cancel my paper.
- I am aware that if I engage in personal attacks, harass another person, or post private information about another person or use mobile technology to bully / threaten other students, whether in school or out of school, I may face exclusion and my actions may constitute criminal behaviour and as such the police could be informed.
- I will not browse, download, upload, forward or receive material that could be considered inappropriate, offensive or illegal. If I accidentally come across such material I will report it immediately to a member of staff.
- I agree to follow Marlborough values and those of British Values whilst using mobile devices which are in my possession.





Student Acceptable Use Agreement Form

(to be signed each year of schooling)

This form relates to the Mobile Technology Agreement to which it is attached.

Please complete the sections below to show that you have read, understood and agree to the rules included in the Acceptable Use Agreement. If you **do not sign** and return this agreement, **access will not be granted** for you to bring in and use your own mobile technology and a confiscated phone will only be returned upon the completion of a lunch time detention, a fully signed agreement form and successful completion of the online e-safety module.

I have read and understand the policy and agree to follow these guidelines when:

- I use the school's ICT equipment (both in and out of school)
- I agree to give the school my mobile number so that this can be used in the event of an emergency or as a result of any safeguarding concerns that the school may have. I also agree to advise the school if my number changes at any point in the future
- I use my own equipment in school (when allowed) e.g. mobile phones, cameras etc.
- I use my own equipment out of school in a way that is related to me being a member of this school
 - e.g. communicating with other members of the school, accessing school email, website etc.
- I agree **not** to contact members of my family during school hours unless given permission to do so by a member of staff.
- I understand that if **I VIOLATE THE ACCEPTABLE AGREEMENT** my mobile communication device will be confiscated by the school in accordance to the schools sanctions and that I may face disciplinary action in line with the school's Behaviour Policy and Procedures.
- I agree to adhere to Marlborough core values and those of our British Values.
- The school may revoke approval or authorised permission or change this policy and procedures at any time and will notify parents / students of this decision.
- I know I must successfully pass the online modules before bringing my device into school and should I contravene this policy I will be asked to resit all of the online safety modules again.
- I agree to use **Edulink** and have the **Edulink app** on my phone with **notifications turned on** to help improve communication about my learning

It is my responsibility for keeping the school informed of my current mobile phone number. (False information given will be deemed to be a violation of this agreement).
